#### Part 1: Introduction

The following Operational Procedures (OPs) stipulate the requirements for catch reporting to Deepwater Group Ltd (DWG) as agreed by quota owners.

Purpose of these Procedures	These OPs have been established so that agreed reporting requirements are clearly communicated to, and understood by vessel captains, vessel managers and quota managers.

DWG Reporting Requirements	Fishery-specific catch reporting requirements:
	<ul> <li>Sub-area catch reporting (ORH2A, ORH3B, OEO1).</li> </ul>
	<ul> <li>Catch reporting by separate species (OEO1, OEO3A).</li> </ul>
	Generic reporting requirements in regard to:
	<ul> <li>Notification of entry to and exit from Hoki Management Areas (see Operational Procedures for the hoki fisheries).</li> </ul>
	<ul> <li>Trigger points – Refer to the Marine Mammals OP (MMOP) and Vessel Management Plan (VMP) for these trigger points in relation to marine mammal and seabird captures.</li> </ul>
	Note: That reporting frequencies are fisheries-specific and may vary by fishery.
Ministry Reporting Requirements	<ul> <li>You are obliged by law to report to the Ministry any captures of protected species on the prescribed Non-fish / Protected Species Catch Return.</li> </ul>

#### Part 2: Reporting Protocols - HOK1

The following outlines the reporting requirements for HOK1.

<b>Hoki Management Area Reporting</b> (non-hoki target in a Hoki Management Area)	No hoki <u>target fishing</u> is permitted within a Hoki Management Area (HMA) (refer to maps in Operational Procedures for Hoki Fisheries).
	Any vessel operator intending to target species other than hoki with a trawler >28 m (LOA) within a HMA <u>shall</u> :
	<ul> <li>Notify DWG of their intention to fish in a HMA</li> </ul>
	<ul> <li>Notify DWG on time and date of entry to and exit from the HMA</li> </ul>
	<ul> <li>Advise if a Ministry observer is on-board</li> </ul>
	Any vessel operator intending to target species other than hoki with a trawler >28 m (LOA) within a HMA and <u>not</u> carrying a Ministry observer <u>shall</u> :
	<ul> <li>On direct request from DWG, provide copies of TCEPRs to DWG</li> </ul>

#### Part 3: Reporting Protocols - ORH and OEO

The following outlines the reporting requirements for ORH and OEO.

ORH Catch Reporting by Sub-Area	<ul> <li>Monthly reporting of catches from designated sub-areas for:</li> <li>ORH2A <ul> <li>North</li> <li>South</li> </ul> </li> <li>ORH3B <ul> <li>Northwest Chatham Rise</li> <li>East &amp; South Chatham Rise</li> <li>Sub-Antarctic</li> </ul> </li> <li>Note: For boundaries of these FMA sub-areas, please refer to Figure 1, Operational Procedures for the Orange Roughy and Oreo Fisheries</li> </ul>
OEO Catch Reporting by Species	<ul> <li>Monthly reporting of catches by species of oreo from:</li> <li>OEO1 Southland sub-area <ul> <li>SSO and BOE/SOR</li> </ul> </li> <li>OEO3A <ul> <li>SSO and BOE/SOR</li> </ul> </li> <li>Note: For boundaries of these FMA sub-areas, please refer to Figure 2, Operational Procedures for the Orange Roughy and Oreo Fisheries</li> </ul>
Reporting Deadlines	Monthly reports are required by the 17 <sup>th</sup> of the month following the date of landing.

### Part 4: Reporting Protocols – SQU1T and SQU6T

The following outlines the reporting requirements for SQU1T and SQU6T.

Pre-Season Reporting SQU1T/SQU6T	The Vessel Management Plan (VMP) internal review form should be completed before 30 September each year.
	The SLED check sheet is required from all vessels by 31 December (to be eligible for your tow discount).
	Note: All vessels are required to give a pre-sailing departure notice to the Ministry (FCC) at least 72 hours before sailing to SQU 6T.
In-Season Tow Reporting	All vessels should report in-season squid tows to the vessel's shore manager for forwarding to DWG:
	<ul> <li>Twice a week (by 17:00 hours every Monday and Thursday).</li> </ul>
	• Daily, if required under the Ministry's Operational Plan.
What to do if trigger point reached?	When a trigger point is reached, as outlined in the Marine Mammal Operational Procedure (MMOP) and VMP, the Captain is required to report any breaches of trigger points within 24 hours to shore management. Shore management will then promptly contact DWG for advice and support.

#### Part 5: Incidental Capture Reporting Protocols – Trawlers >28m

The following outlines the reporting requirements for incidental captures by trawlers over 28 metres.

VMP Trigger Points - Seabirds	As required by the seabird triggers in the VMP, all trawlers over 28 m (LOA) must:
	• Report to DWG, when:
	<ul> <li>3 or more large seabirds (e.g. albatrosses) are captured in a 24-hour period.</li> </ul>
	- 5 or more small seabirds (e.g. petrels) are captured in a 24-hour period.
	<ul> <li>10 or more seabirds are captured in a 7-day period.</li> </ul>
	• Return a VMP Review Form to DWG by 30 September each year.
MMOP Trigger Points – Marine	All trawlers over 28 m (LOA) must report to DWG:
Mammals	<u>All</u> sea lion captures:
	<ul> <li>Notification to DWG via shore manager</li> </ul>
	<ul> <li>Completion of Sea Lion Capture Questionnaire</li> </ul>
	• Fur seal captures – if 2 or more in 24 hours; 5 or more in a 7-day period:
	<ul> <li>Notification to DWG via shore manager</li> </ul>
	<u>All</u> dolphin captures:
	<ul> <li>Notification to DWG via shore manager</li> </ul>
Mandatory Non-fish / Protected Species Catch Return	As required by Fisheries Regulations, all vessels are mandatorily required to complete and furnish to the Ministry a Non-fish / Protected Species Catch Return when any relevant species are captured.
